### **ORDINANCE #1953**

An Ordinance of Bernards Township in Somerset County, New Jersey, Amending the General Ordinances, Chapter IV entitled "General Licensing", to Add New Section 4-12 entitled "Landlord Registration"

**NOW THEREFORE BE IT ORDAINED** by the Township Committee of the Township of Bernards, County of Somerset State of New Jersey as follows:

<u>Section 1.</u> Chapter IV entitled "General Licensing" of the Bernards Township General Ordinances is hereby amended to add new Section 4-12 entitled "Landlord Registration" as follows:

## SECTION 4-12 Landlord Registration

# § 4-12.1 Registration Required.

a. Every landlord renting residential property located within the Township shall, within 30 days of the first tenancy, file a certificate of registration in accordance with the provisions of N.J.S.A. 46:8-28, as may be amended from time to time, with the Development Control Officer/Housing Administrator and provide a copy of the certificate simultaneously to the tenant. The certificate of registration filed shall follow the form below.

- All other ordinances in conflict or inconsistent with this ordinance are hereby repealed, to the Section 2. extent of such conflict or inconsistency. In the event of any inconsistencies between the provisions of this Ordinance and any prior ordinance of the Township of Bernards, the provisions hereof shall be determined to govern. All other parts, portions and provisions of the Revised General Ordinances of the Township of Bernards are hereby ratified and confirmed, except where inconsistent with the terms hereof.
- Section 3. If any article, section, subsection, paragraph, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid by a court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance and they shall remain in full force and effect, and to this end the provisions of this ordinance are hereby declared severable.
- Interpretation: This Ordinance shall be so construed as not to conflict with any provision of New Section 4. Jersey or Federal law.
- This ordinance shall take effect immediately upon adoption and publication in accordance with Section 5. the laws of the State of New Jersey.
