Health Education / Youth Services Coordinator Report - Bernards Township April 2021

Clinics/ Screening Programs

- April 1: COVID-19 PCR Testing at Bernards Township Community Center. 28 people tested using PCR tests. One (1) person was positive for COVID-19 (3.6%).
- April 8: COVID-19 PCR Testing at Bernards Township Community Center. 54 people tested using PCR tests. No individuals were positive for COVID-19 (0%).
- April 15: COVID-19 PCR Testing at Bernards Township Community Center. 58 people tested using PCR tests. Eight (8) people were positive for COVID-19 (13.8%).
- April 22: COVID-19 PCR Testing at Bernards Township Community Center. 28 people tested using PCR tests. No individuals were positive for COVID-19 (0%).
- April 29: COVID-19 PCR Testing at Bernards Township Community Center. 22 people tested using PCR tests. No
 individuals were positive for COVID-19 (0%).
- PCR Testing for COVID-19 continuing to be set up for the foreseeable future in Bernards Township.

Municipal Alliance/Youth Services Commission

- Cancelled April 6th meeting
- K. Cartoccio met with other LMTI advisors on March 1st with LMTI administrative staff to discuss the possibility of the Summer Leadership Conference this summer.
- Posts are regularly updated on the Municipal Alliance Facebook page
- Submitted the Request for Funding for FY 2022 for the Municipal Alliance grant. Funding from the state has been significantly reduced to around \$8,000 due to DEDR (Drug Enforcement fines) collections being low.
- Co-sponsored a virtual screening of "Angst" with other Somerset County Municipal Alliances. About 300 registered and
 participated in the program.
- Promoted DEA RX Takeback Day scheduled for April 24th 10am-2pm. The Municipal Alliance hopes to continue to drop
 off drive in the fall.
- Co-sponsored "Marijuana: What We Don't Know CAN Hurt Our Kids" with Community in Crisis and the Ridge High School PTO. About 100 people attended virtually.
- Grab n Go Teen Outreach
 - o Launched to Bernards Library Teen Advisory Board and REACH members on April 7th and 8th. The kits this month were Kindness Rocks and about 15 students attended the Zoom party on April 9th.
 - O Continued to promote the program to students. The target audience is Bernards Township 7-12th graders. Parents and students can sign up for email and text alerts for when kits are available for pick up or follow REACH and TAB on Instagram.
- REACH met on April 8th. The group continues to work on a social media outreach plan going forward including "Mental Health Monday", "Wellness Wednesday" and "Flashback Friday".
 - o REACH is finishing up a School Stress video and beginning to discuss a Stigma project.
 - o REACH has been utilizing the professional Canva account to create Instagram posts.
 - o 65 WAMS 8th graders were nominated for LMTI and letters were sent in the mail to set up an LMTI Info Session with K.Cartoccio and members of the REACH Leadership team.

COVID-19 Mitigation

- The Vulnerable Populations Outreach Coordinator (VPOC) continues to work to identify the vulnerable populations in our
 jurisdictions and identifying gaps to help address the needs of COVID-19 positive and exposed persons:
 - Helping to connect senior citizens and other homebound residents to vaccination appointments.
 - Continuing to catalog a list of available resources to help vulnerable populations access critical resources such as social services, mental health services, and general healthcare. Also includes access to resources like food banks, mental health services, visiting nurses, telehealth solutions, and other community programs.
 - Prioritizing COVID-19 response initiatives such as COVID-19 testing clinics and preparation for COVID-19 vaccine clinics.
 - Conducting weekly COVID-19 testing clinics to help identify positive COVID-19 cases and ultimately mitigate the spread of COVID-19.
 - Regularly monitoring COVID-19 related data received through testing and contact tracing.
 - Working with other local health department VPOCs in NJ to create collaborative opportunities and resources through monthly meetings.
 - Collaborating with local faith-based organizations to implement vaccination clinics in the community.
 - Reapplying for VPOC funding for 2021-2022.

Vaccine Efforts

- Received a small allocation of Janssen (Johnson & Johnson) vaccine. Had a small clinic scheduled in April
 but was canceled due to the pause. This pause has been lifted and VPOC is working to reschedule the
 clinic
- Over 200 volunteers have been surveyed and cataloged for vaccination efforts. They will be contacted when vaccine becomes available.
- Staff responsibilities for vaccination clinics are continuously discussed and formatted. Vaccine clinic supplies have been purchased and organized for when operations can begin.
- Staff responsibilities for vaccination clinics are continuously discussed and formatted. Vaccine clinic supplies have been purchased and organized for when operations can begin.
- Monitoring COVID daily reporting at local long-term care facilities.
- Applying for a state grant to fund a part-time nurse so that we can increase our COVID vaccine administration capabilities.
- Continued communication with OEM for Bernards Township to discuss security for COVID-19 vaccine clinics.
- Significant time daily has been spent talking to multiple school districts and preschools, nurses, parents, sports teams and leagues, senior housing, businesses, etc. about COVID-19 infections and close contacts advising them who, when, and how isolation and quarantine must take place. We study guidance daily as it changes and attend daily/weekly conference calls on COVID-19 mitigation and procedures to implement with various community health partners and the NJDOH.
- Daily COVID-19 NJ Office of Local Public Health calls and distribution of new info to staff.
- Staying up to date on the COVID-19 vaccination process in New Jersey via daily State led vaccinator calls.
- Continuing to release weekly updates on COVID-19 via RAVE in Bernards Township and to individual entities in other towns. Updates now include weekly numbers for each town and vaccine information. As of the first week of May this will be Update #75.
- Follow-up on contact-tracing in CDRSS conducted by staff. Statistics compiled on COVID-19 infections.

Health Education

- Set up "Farm to Go" CSA for Bernards Township Employees.
- Reserved a physician and location for summer skin cancer screening.
- Virtual programming is being discussed for mental health programs in collaboration with the Bernards Township Municipal Alliance.
