Health Education / Youth Services Coordinator Report September 2021

Testing Clinics/ Screening Programs

- Continuing COVID-19 testing every Thursday.
 - September 2: COVID-19 PCR Testing at Bernards Township Community Center. 34 people tested using PCR tests.
 Three (3) individuals were positive for COVID-19 (8.82%).
 - September 9: COVID-19 PCR Testing at Bernards Township Community Center. 44 people tested using PCR tests.
 Three (3) individuals were positive for COVID-19 (6.82%).
 - September 16: COVID-19 PCR Testing at Bernards Township Community Center. 59 people tested using PCR tests. One (1) individual was positive for COVID-19 (1.69%).
 - September 23: COVID-19 PCR Testing at Bernards Township Community Center. 39 people tested using PCR tests. No individuals were positive for COVID-19 (0%).
 - September 30: COVID-19 PCR Testing at Bernards Township Community Center. 48 people tested using PCR tests. One (1) individual was positive for COVID-19 (2.08%).

COVID-19 Mitigation

- The Vulnerable Populations Outreach Coordinator (VPOC) continues to work to identify the vulnerable populations in our
 jurisdictions and identifying gaps to help address the needs of COVID-19 positive and exposed persons:
 - Helping to connect senior citizens and other homebound residents to vaccination appointments.
 - Continuing to catalog a list of available resources to help vulnerable populations access critical resources such as social services, mental health services, and general healthcare. Also includes access to resources like food banks, mental health services, visiting nurses, telehealth solutions, and other community programs.
 - Prioritizing COVID-19 response initiatives such as COVID-19 testing clinics and weekly COVID-19 vaccine clinics.
 - Conducting weekly COVID-19 testing clinics to help identify positive COVID-19 cases and ultimately mitigate the spread of COVID-19.
 - Regularly monitoring COVID-19 related data received through testing and contact tracing.
 - Working with other local health department VPOCs in NJ to create collaborative opportunities and resources through monthly meetings.
 - Collaborating with local faith-based organizations to implement vaccination clinics in the community.
 - Reapplying for VPOC funding for 2021-2022.

Vaccination Efforts

- Vaccine clinics (J&J only) conducted every Wednesday in September at the Bernards Township Community Center. A second-dose Pfizer clinic was also held in September at St. James Church in BT.
- Contacting volunteers as needed according to skills, such as Spanish-speaking or nursing license.
- Staff responsibilities for vaccination clinics are continuously discussed. Clinic supplies have been assessed and prepared to ensure we can continue vaccinating the local population.
- Worked with a local pharmacist to train nurses on proper reconstitution and administration of the Pfizer vaccine.
- Received additional vaccine allocations J&J and Pfizer.
- September Clinic List:
 - September 1- Bernards Township Community Center: 9 J&J
 - September 8- Bernards Township Community Center: 7 J&J
 - September 13- Bernards Township Community Center:43 Pfizer
 - September 15- Bernards Township Community Center: 16 J&J
 - September 22- Bernards Township Community Center: 6 J&J
 - September 29- Bernards Township Community Center: 7 J&J
- Monitoring COVID daily reporting at local long-term care facilities.

- Significant time daily has been spent talking to multiple school districts and preschools, nurses, parents, sports teams and leagues, senior housing, businesses, etc. about COVID-19 infections and close contacts advising them who, when, and how isolation and quarantine must take place. We study guidance daily as it changes and attend daily/weekly conference calls on COVID-19 mitigation and procedures to implement with various community health partners and the NJDOH.
- Weekly COVID-19 NJ Office of Local Public Health calls and distribution of new info to staff.
- Staying up to date on the COVID-19 vaccination process in New Jersey via daily State led vaccinator calls.
- Continuing to release bi-monthly updates on COVID-19 via RAVE in Bernards Township and to individual entities in other towns. Updates now include weekly numbers for each town and vaccine information. As of October 5th, there have been 88 updates.
- Follow-up on contact-tracing in CDRSS conducted by staff. Statistics compiled on COVID-19 infections.
- Completed two presentations for school nurses. One presentation was offered for Morris County School Nurses in our jurisdiction. The other was for all Somerset County School Nurses. Presentations discussed new school guidelines in detail and answered many questions.

Health Education

 Preparing for fall flu clinics. Created flyer, press release, and road signs. Sent out advertising and began fielding questions from community members. Reviewing protocols and needed supplies. Following up on flu vaccine order to determine arrival date.

Municipal Alliance/Youth Services Commission

- Met on September 7th via Zoom. REACH students who attend the Lindsey Meyer Teen Institute Summer Leadership Conference shared their experiences with Municipal Alliance members and thanked them for their scholarships.
- Posts on the Municipal Alliance Facebook page and REACH Instagram page are updated regularly sharing information and other local programs.
- Grab n Go Teen Outreach
 - September kit Autumn Mason Jar Luminary pick up was scheduled for September 22nd and 23rd. 50 kits were made and picked up by local students.
 - Planning to apply for a second year of Grab n Go Teen Outreach
- REACH met on September 14th and September 29th. Members reviewed the focuses that were discussed at the Summer Leadership Conference including: drinking and drug use (focusing on vaping), mental health stigma, LGBTQ matters and environmental concerns.
- The Municipal Alliance will have their annual Municipal Alliance Football Game on October 15th.
- DEA Drug Takeback Day is scheduled for Saturday, October 23rd and will be a drive thru drop off.
- The MA and REACH will be present at the Mayor's Fall Festival on October 2nd.

ORDINANCE BH: 108

AN ORDINANCE OF THE BOARD OF HEALTH OF THE TOWNSHIP OF BERNARDS, COUNTY OF SOMERSET, AMENDING CHAPTER BH:10, DOMESTIC ANIMALS TO REQUIRE OUTDOOR CATS TO BE NEUTERED

WHEREAS, a community with outdoor cats who are not neutered may experience considerable costs associated with trapping, providing veterinary care and sheltering for outdoors cats; and

WHEREAS, outdoor cat populations result in numerous nuisance complaints being filed with the Board as well as a rise in euthanasia rates for all cats since adult unsocialized cats are not generally adoptable.

NOW, THEREFORE, BE IT ORDAINED by the Board of Health of the Township of Bernards, in Somerset County, New Jersey as follows:

SECTION 1. Chapter BH:10, Domestic Animals, Section BH:10-5, Cat Licensing Code, of the Revised Ordinances of the Board of Health, Township of Bernards, County of Somerset, State of New Jersey, is hereby amended by the addition of a new subsection BH:10-5.4, to read as follows:

"BH:10-5.4. Mandatory neutering of outdoor cats.

- a. No person may own, keep or harbor a cat in violation of this ordinance.
- b. It shall be unlawful for an owner or custodian of a cat over the age of four months to allow such cat to be at large unless the cat has been neutered by a veterinarian, or unless the terms of paragraph c. below are met.
- c. The owner or custodian of a cat that is unable to be neutered without a high likelihood of suffering serious bodily harm or death due to age, infirmity or particular health risks

must obtain a written confirmation of that fact from a licensed veterinarian and present same to the Board of Health.

SECTION 2. The existing subsection BH:10-5.4, Violations and Penalties, shall be redesignated as subsection BH:10-5.5, Violations and Penalties.

SECTION 3. All Ordinances of the Board of Health of the Township of Bernards that are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 4. If any section, subsection, sentence, clause of phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

SECTION 5. This ordinance maybe renumbered for codification purposes.

SECTION 6. This Ordinance shall take effect immediately upon final passage, approval and publication as required by law.
