As an advisory body, the EC continued to provide commentary to the Planning Board, Board of Adjustment, and Township Committee regarding environmental impacts and issues. During 2018, the EC Analyzed 14 Development Applications (Board of Adjustment/Planning Board Applications)

2018 Accomplishments

The EC accomplished its mission in 2018 through the following initiatives:

Development Application Reviews

The EC reviews and comments on environmental concerns related to property development applications. The EC comments within 2018 calendar year emphasized green infrastructure to promote storm water infiltration and suggested stormwater best management practices to protect wetlands and surface water bodies. When applicable, the EC noted that NJDEP Land Use Permits requirements be considered for development applications.

Tree Removal Applications

The EC works cooperatively with the Township's Shade Tree Commission and Engineering Department to assess proposed tree removal applications. The assessments focus on any safety issues associated with the tree; the health of the tree; and overall appropriateness of the removal requests. Typically tree removals are completed in conjunction with replacement/mitigation measures.

Public Comment

A public comment period is set aside in each meeting, which allows citizens to bring environmental questions and concerns to the attention of the EC the public comments are recorded in the meeting minutes and, as appropriate, the EC advises the citizen(s) on the question itself or directs them to the proper Township personnel.

Charter Day

Charter Day was cancelled in 2018 due to inclement weather. The EC will participate in the 2019 Charter Day and select an environmental theme for display. In the last few years, energy efficiency and backyard composting has been highlighted.

The EC looks forward to continuing to serve Bernards Township and its residents in 2019.

WHEREAS, Bernards Township Ordinance §4-9.1 provides that the purpose of Ordinances §4-9.1 to 9.14, inclusive, is to "license and regulate quarries for the protection of persons and property" and among other things, "to insure that quarried areas shall be suitably and reasonably rehabilitated after quarrying operations have been completed or otherwise terminated"; and

WHEREAS, Bernards Township Ordinances §4-9.3, §4-9.4, §4-9.5 and §4-9.10 provide that a property owner engaged in the "business of quarrying within the township" must first obtain and maintain a current annual license, and prior to the issuance of any such annual license, obtain the township's "approval" of either an initial or renewal "Rehabilitation Plan"; and

WHEREAS, Bernards Township Ordinance §4-9.6(b) provides that "[p]rior to the approval of any new or renewal license application, the applicant shall agree in writing to rehabilitate the quarry property and shall provide security sufficient to adequately assure the ability to comply with the [last approved] rehabilitation plan"; and

WHEREAS, Bernards Township Ordinances §4:9-1, §4-9.5(a)(1), 4§-9.5(b)(8), §4-9.5(b)(9), §4-9.6(b) provide that the last approved rehabilitation plan shall be implemented when quarry operations cease; and

WHEREAS, Bernards Township Ordinance §4-9.5(d) provides that "[i]f the responsible person(s) do not implement the rehabilitation plan in accordance with the schedule in the approved plan, and there is a delay of more than 12 months, then the township may undertake the rehabilitation using the security provided under Subsection 4-9.6" and

that "[t]he Township Committee may permit extensions of the rehabilitation plan where proven reasonable and appropriate"; and

WHEREAS, Millington Quarry, Inc. ("MQI") is the record owner of the Millington Quarry ("the Quarry"), which consists of approximately 190 acres and is identified on the tax map as Block 6001, Lot 6 located at Stonehouse Road in Bernards Township (the "Property"); and

WHEREAS, MQI has, for years, applied for and obtained a license to quarry at the Property, and in connection therewith, MQI submitted its 2011 Rehabilitation Plan (the "2011 Plan") to the Bernards Township Committee on October 17, 2011, and the Township Committee thereafter referred the 2011 Plan to the Bernards Township Planning Board (the "Board") for review and report pursuant to ordinance §4-9.5.a.4 and §4-9.5.a.2; and

WHEREAS, on May 7, 2013, the Bernards Township Planning Board adopted the Report of the Bernards Township Planning Board to the Bernards Township Committee on the Review of the 2011 Millington Quarry (MQI) Rehabilitation Plan (the "IRP"); and

WHEREAS, on April 29, 2014, the township approved a settlement agreement and release by and between Bernards Township and MQI involving certain disputes, including the terms and conditions of the rehabilitation plan (the "Settlement Agreement"); and

WHEREAS, the Settlement Agreement provides that the approved rehabilitation plan consists of the terms and conditions set forth in the IRP, as modified by the Settlement Agreement (the "Last Approved Plan"); and

WHEREAS, MQI ceased its quarrying operations and terminated its license on or prior to October 31, 2016, and thereafter it was required to implement the Last Approved Plan; and

WHEREAS, on May 1, 2009, MQI entered into a Memorandum of Agreement ("MOA") with the New Jersey Department of Environmental Protection ("DEP") to obtain DEP oversight of cleanup activities for a portion of the Quarry property ("the Property") identified as the "Area of Concern" ("AOC") in the Remedial Investigation Work Plan ("RIWP") prepared by JM Sorge dated April 2009, for the purpose of assessing the quality of non-native fill material imported to the Quarry; and

WHEREAS, the Property is the subject of the MOA and DEP's jurisdiction, the Property's planned 50 acre lake area will cover approximately half of the MOA area (about 24 acres), leaving the Property's remaining 26 acres of lake area and 95 acre meadow area of concern to the Township and, therefore, the Quarry Advisory Task Force is charged with monitoring of the Property's environmental condition and status and making appropriate recommendations to the Township Committee; and

WHEREAS, MQI retained a Licensed Site Remediation Professional (LSRP) to oversee and conduct remediation of the AOC and the Property, and the LSRP filed a Response Action Workplan ("RAWP") dated September 2010, and issued a Response Action Outcome ("RAO") on December 13, 2018; and

WHEREAS, there is a substantial public interest in ensuring that the site is properly remediated in accordance with the MOA, RAWP, RIWP, RAO, and other filings with the DEP in this matter and in accordance with the applicable governing statutes and regulations.

NOW THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Bernards that the Quarry Advisory Task Force is established and shall (1) review and report back to the Township Committee with their findings, any concerns, and recommendations, regarding MQI's compliance with implementing the Last Approved Plan; and (2) further review the Property's environmental condition, documentation, and status, and make appropriate recommendations to the Township Committee in one or more reports on or before October 1, 2019, and the Township Committee may pursue outside professionals for technical input; and (3) advise on remediation status in accordance with the MOA, RIWP, RAWP, the RAO, and all other DEP filings in this matter, the governing statutes, regulations, and ordinances; and

NOW THEREFORE BE IT FURTHER RESOLVED that the Quarry Advisory Task Force shall consist of the following, appointed for a one year term expiring 12/31/19:
