PRESENTATION

Settembrino Architects - Elevator for Municipal Building

Kevin Settembrino, from Settembrino Architects, gave a presentation with 3 options to add an elevator at the Municipal Building. Option 1 has the elevator entrance on the east side of the building utilizing the Courtyard for the elevator shaft. This would result in minimal visual impact on the other 3 facades of the existing complex but would result in remote access from the main circulation of the building and require excavation in a difficult to access location, increasing costs and project time. Estimated cost is 1M to 1.1M. Option 2 has the elevator entrance on the east side of the building but built outside the existing building necessitating the re-location of HVAC equipment and resulting in adding a new circuitous circulation routes on the side of the existing building. Estimated cost is 1M. Option 3 is on the west side of the building and would have a large visual impact on both the south and west sides, however the façade could be made to blend with the existing style. The elevator shaft would be outside the building, just outside the Warren Craft meeting room, with options to access all levels but the top floor of the mansion and would include adding a circulation route to the second floor of the mansion. Estimated cost is 600K. All agreed that Option 3 would be the best and directed Engineer Timko to advance the proposal to the next step which would be the design stage.
