The project limits are from the intersection of Pond Hill Road, a combined distance of 1.13 miles, to the intersection of Haas Road, or such portion thereof as may be approved by the Commissioner of Transportation; and

WHEREAS, the total cost estimate for these improvements is \$1,249,736.00. The Township requests the full amount of \$1,249,736.00 in State funds; and

WHEREAS, any aid received as a result of this application will only be used for eligible costs of the project;

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of Bernards Township, formally approves the grant application for the above stated project.

BE IT FURTHER RESOLVED that the Township Engineer and Municipal Clerk are hereby authorized to submit an electronic grant application identified as <u>MA-2022-Keats Road</u>, <u>Highland Avenue</u>, <u>and Tha-00491</u> to the New Jersey Department of Transportation on behalf of the Township of Bernards.

BE IT FURTHER RESOLVED, that the Mayor and Municipal Clerk are hereby authorized to sign the grant agreement on behalf of the Township of Bernards and that their signature constitutes acceptance of the terms and conditions of the grant agreement and approves the execution of the grant agreement.
