# Youth Services Commission – Monique Sprague

# **AGENDA ITEMS**

# a. Community In Crisis Community Needs Assessment Results

Toni Knoll provided a background concerning the survey. She also introduced Amy Harris, an epidemiologist with Epiphany Community Services who shared highlights from the survey and other factual information.

- Overdose deaths increased 30% in Somerset County in 2020 attributable to opioids and Fentanyl
- Parents expressed concern regarding their children's mental health, demonstrating the greatest concern with the 19-22 age group.
- Parents not seeing the link between mental health placing children at higher risk for using substances.
- Counsellors in mental health are seeing students struggling, isolated and less engaged which are all predictors of substance use disorders.
- Parents are greatly concerned about substance use among youths, concern was expressed for all substances.
- Drilling down a bit further, parents are less concerned about their own children using substances.
- This is concerning because if parents do not perceive their child is a risk, they will not seek education.
- Somerset Hills has a culture of drinking and binge drinking.
- Parents did not believe alcohol use was not appropriate. While most parents won't host a party, they were willing to drop their child off at a party where alcohol will be served because of no perceived options.
- Marijuana use was used by over ½ the Somerset Hill students surveyed which is higher than the national average.
- Somerset Hills enjoys a successful and affluent population. Parents have high expectations for their children creating a culture of achievement which can increase anxiety. Thus, Somerset Hills youth are at high risk for substance use and mental health issues.
- Prevention messaging that focuses on substance use as detrimental to achievement may serve as strong motivation against use.
- Incorporating messages into other topics and from several angles. For example: social hosting: peer pressure angle and insurance liability angle.

The presentation was followed by group discussion including topics concerning efforts to start messaging early in elementary school and reconvening parents education.
