### **Old Business**

#### Spotted Lantern Fly Traps

- The Environmental Commission's workshop on 5/24 at the Community Center resulted in sixty spotted lantern fly traps.
- The traps were placed in three parks – Mountain, Dunham and PVP on June 2<sup>nd</sup> by the Ridge senior students on their Ridge High School Gives Back Day.
- Randy, Al, and Kate, along with Todd Edelstein, Nancy Cook and Deb DeWitt of the Environmental Commission worked with the students and explained how to attach traps to the trees.
- The traps will be up for June and July and removed by DPW.
- Al checked some of the traps and found various insects including spotted lantern flies and leafhoppers.
- If it is decided to keep the traps, Kate has offered space in her barn for storage. The traps could be collected in late July and placed in bins.
- Next spring discuss strategy of trap placement.

#### Salem Oak seedling

- Jack planted and is caring for it.
- Signs are being made for these seedlings. Wait to see if it is viable before getting a sign.

#### Tree City USA

- 17-year stickers have been attached to the signs.

#### 20 Trees in the center of Basking Ridge

- The original walking map of twenty trees needs to be updated.
- Kate agreed to update the map and info.
- Should we attach new tree tags to the trees? Some of the existing tags need to be replaced.
- The original tree tags were made at Reeves Arboretum. It was estimated that the cost was \$7 per tag with an additional setup fee.

- Goal – have the list ready for next year's Charter Day.
