OLD BUSINESS

a. Status on Current Projects

i. Public Outreach

Nothing new to report. There will be a stronger social media push in the fall. There was some discussion surround spotted lanternflies and destroying them at their current stage.

ii. Reusable Bag Design Challenge

Debra DeWitt thanked Joan Bannan for dialing in and John Crane and Alice Smyk for attending the Township Committee meeting where the winners of the reusable bag challenge were announced. Debra DeWitt spoke about possibly creating decals with

some of the winner's designs and whether or not that should be pursued. She also repeated where to pick up this year's reusable bags.

iii. EC Comments on the 2019 Reexamination Report

John Crane said he would check to see if the 2020 Reexamination Report was sent, not 2019 report.

NEW BUSINESS

- 1. Marchelli – ZB 21-026 – 35 Normandy Ctt** – Pool not located behind the rear building line of an adjacent dwelling.

Joan Bannan stepped away at 7:26 pm. Regarding this application, pool water discharge may result from backwashing of filters, or from the draining of swimming pools at the end of season, or during maintenance. This water often contains pool treatment chemicals that can cause damage to the receiving environment in the form of non-point source pollution. Therefore, the Environmental Commission wants township residents to use the best management practices available when discharging pool water.

Motion by Nancy Cook, seconded by John Crane.

All in favor, motion carried.

- ii. Ferrier – ZB 21-027 – 107 Childs Rd -** Bulk variances for addition.

Joan Bannan returned at 7:45 pm. Even though the application does not add greater than 1,000 sf of impervious coverage, the Environmental Commission is concerned that this property already exceeds the maximum allowable impervious coverage allowed with more to be added. Increased impervious coverage increases the volume (quantity) of stormwater runoff, which can contribute to local and potentially area-wide flooding. Site drainage is a concern therefore site features to promote stormwater infiltration such as the installation of a seepage pit or other green stormwater management practices for homeowners be considered to help mitigate risk.

- iii. Porr – ZB 21-028 – 10 Prospect Ave** – Bulk variances for installation of in-ground pool.

With regard to this application, pool water discharge may result from backwashing of filters, or from the draining of swimming pools at the end of season or during maintenance. This water often contains pool treatment chemicals that can cause damage to the receiving environment. Therefore, the Environmental Commission wants township residents to use the best management practices available when discharging pool water. Even though the application does not add greater than 1,000 sf of impervious coverage,

the Environmental Commission is concerned that this property already exceeds the maximum allowable impervious coverage allowed with more to be added. Increased impervious coverage increases the volume (quantity) of stormwater runoff, which can contribute to local and potentially area-wide flooding. Site drainage is a concern therefore site features to promote stormwater infiltration such as the installation of a seepage pit or other green stormwater management practices for homeowners be considered to help mitigate risk.

iv. Haley – ZB 21-029 – 5 Dawn Dr – Lot coverage variance for addition.

With regard to this application, the Environmental Commission suspects that all the pool water will be drained to expand the existing pool. This water often contains pool treatment chemicals that can cause damage to the receiving environment. Therefore, the Environmental Commission wants township residents to use the best management practices available when discharging pool water. Even though this application does not add greater than 1,000 sf of impervious coverage, the Environmental Commission is concerned that this property already slightly exceeds the maximum allowable impervious coverage allowed with more to be added. Increased impervious coverage increases the volume (quantity) of stormwater runoff, which can contribute to local and potentially area-wide flooding. Site drainage is a concern therefore site features to promote stormwater infiltration such as the installation of a seepage pit or other green stormwater management practices for homeowners be considered to help mitigate risk. The Environmental Commission notes the lack of a tree removal plan and asks that applicant discuss with the Zoning Board what trees, if any, will be removed and if any will be replaced. The Commission recommends native hardwood species should be planted whenever practical.

Motion by John Crane, seconded by Nancy Cook.

All in favor, motion carried.

v. Pumpkin Smash – Around this time last year the idea for a town-wide pumpkin smash was brought up at the Environmental Commission. Recording Secretary Kaitlin Cartoccio offered to help host the event with her student group, Ridge Education Action & Community Health (REACH) and advertise through her program with the Bernards Township Library, Grab n Go Teen Outreach. The event could be used as a stress relief for not only the teens impacted by GNG but other residents can be invited. Jason Roberts mentioned that a local farm may be interested in co-sponsoring. Debra DeWitt mentioned that the pumpkins need to be composted and disposed of properly. Members will work offline to coordinate and advertise the Pumpkin Smash tentatively scheduled for November 1st 3:30-5 pm.

Jason Roberts asked if the Environmental Commission can lobby for more frequent recycling than every 2 weeks. The group agreed that may be difficult. Ellen Houlihan is the new secretary. Ann Parsekian will be recognized at the second September meeting. John Crane mentioned that they should write a thank you note for Ann. Sarah Wolfson spoke about the Invasive Species task force at the Environmental Education Center. The two high school students who were interested in a community garden may not be able to make it work but have been going to the invasive species pulling. They may be interested in guerilla gardening and becoming junior members of the Environmental Committee. Nancy Cook congratulated Debra DeWitt and Alice Smyk on their new positions. Debra DeWitt mentioned wanting to work more cohesively in looking at applications and taking notes. Todd Edelstein mentioned that all the applications can be split amongst members, and they could each take the lead on discussions.

Marchelli – ZB21-026, 35 Normandy Court

With regard to this application, pool water discharge may result from backwashing of filters, or from the draining of swimming pools at the end of season or during maintenance. This water often contains pool treatment chemicals that can cause damage to the receiving environment. Therefore, the Environmental Commission wants township residents to use the best management practices available when discharging pool water.

Ferrier – ZB21-027, 107 Childs Road

While this application does not add greater than 1,000 sf of impervious coverage, the Environmental Commission is concerned that this property already exceeds the maximum allowable impervious coverage allowed with more to be added. Increased impervious coverage increases the volume (quantity) of stormwater runoff, which can contribute to local and potentially area-wide flooding. Site drainage is a concern therefore site features to promote stormwater infiltration such as the installation of a seepage pit or other green stormwater management practices for homeowners be considered to help mitigate risk.
