BTSA ENGINEER'S REPORT March 2018 Meeting

DEVELOPER PROJECTS:

Silverman Group/North Maple Avenue

Final site restoration inspection will be made in the spring.

Fellowship Senior Living

The lateral installation has not been completed by the Contractor and despite following up for a schedule; we have not been informed of a completion date.

Christopher Bell Subdivision (Valley Road)

Revised application materials from Finnelli Engineers have been reviewed and commented upon.

AUTHORITY PROJECTS:

Monarch Circle (Crown Court) Pump Station

Although some site restoration has begun and additional coordination with JCP&L, the station experienced a power disruption after the March 1 Nor'easter. During the Nor'easter, the station experienced high-flows and the Contractor's pump vendor provided emergency diagnostic services regarding a reduction in pump performance. We await the results from further diagnostic testing to see if replacement equipment is needed. JCP&L power is also down as of 3/7/2018. Mott has worked closely with BTSA to obtain the necessary diagnosis and repair from the utility company despite the difficult conditions arising from the storm events. We expect continued JCP&L work for the new primary service installation and site restoration. We do not have an updated completion date from the Contractor.

Harrison Brook STP-RAS/WAS Rehabilitation

Key equipment and material have been and are in the process of being delivered to the site.

Harrison Brook STP-1M Belt Filter Press Building Demolition

Mobilization and site preparations have begun.

Harrison Brook STP-Capacity Assurance

A letter is being sent to NJDEP requesting discontinuance of quarterly flow reporting.

Revised application materials and communication with Finnelli Engineers continues to perfect their application for sewer service.

Power upgrades are completed. The new station requires a final testing regiment that is scheduled for the week of April 9th. UST tank has been removed. The contractor's 4/4/2018 correspondence to our office indicates he intends on completing final site restoration as soon as the weather breaks.

Key equipment and material have been and are in the process of being delivered to the site. Construction is on schedule.

Harrison Brook STP-1M Belt Filter Press Building Demolition

Demolition work is near complete. Electrical work continues.

A letter was sent in March regarding the discontinuance of flow reporting to NJDEP. We await response.
