j. Discussion – quarterly flow report

First quarter flows are high because of the amount of rain we've had in the last 8 months. The second quarter flows are dropping with less rain. They have gone from 2.6 down to 2.3.

k. Discussion – grease trap waivers

There are 54 grease traps in town and the authority does 216 inspections a year. They spend about 3 days a quarter on inspections, about 100 hours of manpower a year, which is minimal. There was a question about whether we should charge a fee and the authority members agreed no fee will be required.

Language needs to be drafted to be put into the regulations for the grease trap waiver to include "at the sole discretion of the authority". Timko will draft for the next meeting.

Mott MacDonald is currently prepared to assist BTSA with its discharge permit renewal. The permit expires in June 2020 and the renewal submission is 180 days prior. The renewal process usually involves a combined effort of administration, operations, engineering and legal.
